Funds were awarded to three agencies - the Housing Authority of Snohomish County (HASCO), the City of Monroe and Parkview Services. 1) HASCO will provide owner-occupied housing rehabilitation to approximately five (5) low- to moderate-income homeowners with income at or below 80% of the area median income residing in Snohomish County, outside the cities of Everett and Bothell. Loans will be used to provide energy efficiency and conservation improvements and critical health and safety repairs. Funding will support approximately 16 temporary FTE construction and related jobs. 2) The City of Monroe will construct 700 linear feet of five-foot wide sidewalks with a four-foot wide landscaping strip, curb, gutter and necessary storm water improvements. The project is located on West Columbia Street between King Street and Dickinson Street. It is estimated that the funding will support 5 temporary FTE construction jobs for one month. 3) Parkview Services will acquire and rehab a single family home with three bedrooms that will provide permanent supportive rental housing for adults with developmental disabilities with incomes at or below 30% of the area median income. Rehab will consist of ADA modifications, health and safety improvements, and energy efficiency improvements, if needed. The scope of the rehabilitation will be expanded and will include renovating the unfurnished daylight basement into an additional unit that is ADA-accessible. It is estimated that the funding will provide 4 temporary FTE construction jobs for one month. It is anticipated that an additional 8 - 10 permanent supportive service positions will also be created. 4) Snohomish County will use \$82,581 to provide planning and administration of the CDBG-R program.

Parkview services has selected and hired the contractor to rehabilitate the building, but is waiting for the permit to begin. Parkview services did not create or retain any jobs this quarter. Snohomish County administration retained .11 FTE this quarter in administrative jobs. The HASCO project contract was executed on March 30, 2011. The HASCO project has identified several homes to rehabilitate, has completed one home and begun rehabilitation on a second home this quarter. HASCO retained .3 FTE this quarter.</p>
